The results are as follows: 58.02% of the system is in good condition. 24.68% of the system is in fair condition. 9.67% of the system is in poor condition. 7.63% of the system is considered Blocked. The Field crew is working on a plan to address all blocked lines and lines considered to be in poor condition. The District Manager also reviewed the mapping system provided by RH Borden with the Directors.
