S-0. <u>4249 College View Sanitation Line</u> –Action Item (Niles)

The customer at 4249 College View believes the slip-line repair done on the District's mainline in 2019 by Leo Sewer and Drain blocked the service line tap. The customer has paid a contractor to excavate and repair the service line and tap. The District believes there was no issue from the slip-line and that it's not the responsibility of the District. Customer has addressed the Board in December and requested compensation for the repairs. This issue was tabled until the January Board Meeting by President Colgrove at the December Meeting so the Board could consult with legal counsel.

Suggested motion "... to **approve or deny** the request for the \$15,000 in reimbursements from the customer at 4249 College View.
